
SPECIFICATIONS:

- Item No. 1: SECTION 01 5200 - SECURITY AND SAFETY, paragraph 1.3, A.
Replace Item 4 with the following, "Construct all temporary barricades, fencing, gates, and controls in accordance with applicable security requirements. Contractor may use airport barricades and temporary fencing, but shall be fully responsible for all damage or loss of such barricades and temporary fencing."
- Item No. 2: SECTION 01 5200 - SECURITY AND SAFETY, paragraph 1.3, A.
Add the following sentence to the end of item number 5, "Contractor will utilize Gate F for delivery of equipment and materials to the Electrical Service area."

DRAWINGS:

- Item No. 1: SHEET C0.1 GENERAL NOTES, ABBREVIATIONS AND SYMBOLS
Revise Spec Section 10 5000 in Note 11 to read, "Spec Section 01 5000."
- Item No. 2: SHEET C0.1 GENERAL NOTES, ABBREVIATIONS AND SYMBOLS
Add Note 15 to read, "Barricades and/or temporary fencing that comply with FAA requirements shall be used to define and control Work areas. Contractor may utilize JNU Airport owned barricades and/or temporary fencing."

- Item No. 3: SHEET C2.0 SITE DEMOLITION PLAN
Remove the reference to Demolition note D at the dashed line that extends northwesterly from the northwest corner of the SAWCUT & MTE line.
- Item No. 4: SHEET C2.0 SITE DEMOLITION PLAN
Revise 3"-5" THICK" on Note A to read, "3"-7" THICK."
