Hello! I'm responding to the request to share information about how my business has been impacted by Covid and related issues. I am a massage therapist and somatic coach. I have lost about 95% of my income for two reasons: First, two people in my family are at an increased risk for Covid complications due to lung and inflammation issues. As a result, my husband and I decided that I should no longer provide massage during this time. Second, I am currently at home with my children since school is not in session. This means that my capacity to see coaching clients online is greatly diminished, as is my capacity to complete courses for graduate school. As a result, my graduation and future employment as a psychotherapist has been delayed by six months.
