No person may operate a marijuana establishment within the City and Borough without a conditional use permit, a valid license issued by the City and Borough, and a valid license issued by the State of Alaska. Upon denial or revocation of a marijuana establishment license issued by the State of Alaska, any license issued by the City and Borough under article 49.65.1105 shall be null and void. If a court of competent jurisdiction determines that the issuance of local licenses violates State or federal law, all licenses issued under article 49.65.1105 shall be deemed immediately revoked by operation of law, with no ground for appeal or redress on behalf of the licensee. Under article 49.65.1120, no license granted or issued under any of the provisions of this title shall be in any manner assignable or transferrable. Licenses issued are effective from the date of issuance through December 31 of the same year. In order to be eligible for renewal, a licensee must submit proof of inspection by the department or the department's designees for compliance with this chapter and any applicable permit. The licensee shall schedule the inspection no later than sixty days prior to the annual expiration of the license. Licenses shall automatically renew on January 1, conditional upon the timely remittance of the annual license fee and proof of inspection. Failure to timely remit proof of inspection or the annual license fee shall result in the license expiring and will require a new license application.

I acknowledge I have read and understand the above statements concerning the application and obtainment of a marijuana license with the City and Borough of Juneau. Also, I am verifying compliance with any buffer requirements imposed by 3 AAC Chapter 306 of the Alaska Administrative Code. I also acknowledge that it is my responsibility and the responsibility of my agents and employees to comply with the provisions of the City and Borough of Juneau Municipal Code and all Rules and Regulations which govern my Marijuana Establishment License Application.
