Before beginning the candidate petition process, please familiarize yourself with the Alaska Public Offices Commission (APOC) https://doa.alaska.gov/apoc/ statutes and filing requirements for campaigning as well as Public Official Financial Disclosure (POFD) Statements. Check online at or by contacting APOC directly via email apoc@alaska.gov or via telephone at 907-276-4176.

The Assembly has directed the Clerk to conduct the October 5, 2021 Regular Municipal Election as a By Mail Election. As such, CBJ Code 29.07.370 governs the timing of the election and the candidate filing period. Candidate nominating petitions can be printed and signatures gathered any time prior to the closing of the Candidate Filing Period provided the completed petition packet is filed with the Clerk's office no later than the closing of the candidate filing period. The Candidate Filing period opens at 8:00 a.m. on Friday, July 16, 2021 and closes at 4:30p.m. on Monday, July 26, 2021. Candidate filing packets must include the Declaration of Candidacy Statement, Nominating Petition signed by a minimum of 25 registered Juneau voters, and the Alaska Public Offices Commission Public Official Financial Disclosure Statement.

Per, CBJ Code 29.07.050, Candidates may withdraw their nomination not later than 4:30p.m. on Friday, July 30, 2021.

CBJ Code 29.07.370 also provides candidates the option to submit an official candidate statement to be published on the municipal website under 29.07.055. https://bit.ly/3orUsPC Candidates are asked to submit their candidate statements to the Municipal Clerk's office no later than August 20, 2021.
