# **Project Timeline**

- Current downtown hazard maps are dated September 1987, based on maps from the 70s. CDD was awarded a grant from the Federal Emergency Management Agency in 2018 to update the maps with a new study.
- Field work was conducted by the contractor, Tetra Tech Inc., in 2019
- First draft of the report was received in August 2020.
- The third draft was formally released to the public on the CDD Special Projects website on July 9, 2021

#### Landslide and Avalanche Assessment

#### Project Overview

CBJ's current hazard maps, adopted in 1987 for downtown Juneau, are based on maps created in the 1970s. These low-resolution maps combine landslide and avalanche areas into a single map which identifies moderate and severe hazard areas. CDD received a grant from the Federal Emergency Management Agency (FEMA) to update these maps with current scientific analysis, and to evaluate landslide and avalanche areas separately. Tetra Tech Inc. has been hired as the contractor. CDD will develop detailed draft policies and regulations to accompany the draft hazard maps at a later date under a separate contract. At this time, CDD is proposing only the minimum regulatory changes necessary for adoption of the new maps.

#### Neighborhood Meeting, Wednesday July 21, 2021, 6-8 PM

The public review draft of the maps will be presented to project area property owners, business owners, and other interested parties at virtual meeting with CDD and the contractor on Wednesday July 21, 6-8 pm. A postcard mailing will be sent to residents and business owners in the project area approximately one week before the mailing.

# **Current Hazard Regulations**

CBJ Code 49.70.300(b) Landslide and Avalanche Areas

(1) Notwithstanding any other provision, no development or any part of a development, which is within a severe avalanche area shall, by the addition of bedrooms, conversions of buildings, or otherwise, increase the density of that parcel; provided, however, that a single-family house may be constructed on a vacant lot.

(2) No subdivision shall be approved which creates a lot lacking sufficient building space outside a severe avalanche area.



The currently adopted hazard maps combine avalanche and landslide areas, so the development applies to severe landslide as well as severe avalanche areas.



## Current Hazard Regulations—Appeal Process

#### CBJ 49.70.300(a)(4)

If a developer disagrees with the boundaries shown on the maps, the developer may seek departmental relocation of the boundaries by submitting site specific studies prepared by a civil engineer experienced in avalanche and landslide analysis. Such studies shall include detailed analyses of topography, vegetation, potential snow accumulation, and other factors. The results should indicate actual hazard area boundaries and potential debris flow direction, time, distance and mass. If, in the opinion of the city engineer, the studies clearly establish that the map boundaries are inaccurate and the proposed development is outside a severe avalanche area or outside any avalanche or landslide area, the department shall proceed accordingly.

#### No changes are proposed to this section.



# **Proposed Map Update**

CDD is proposing the minimum regulatory update to replace the September 9, 1987 maps in the code with the proposed May 28, 2021 maps.

This update includes applying development restrictions to severe avalanche areas, and to severe and high landslide areas. This is necessary because the new study identifies three avalanche hazard designations (severe, moderate, and low), and four landslide designations (severe, high, moderate, and low). The 1987 maps combine avalanche and landslide areas.



# **Proposed Map Update**

The currently adopted study has severe, moderate, and low categories combined for landslide and avalanche. The new study is more precise and separates these areas, because they don't always overlap.

 CDD will conduct a separate review of hazard policies, regulations, and potential engineering interventions and mitigation through a separate grant and competitive bid process in 2022.
