Chief's Message

On behalf of the sworn and civilian support staff members who collectively serve our community, it is my pleasure to present the Juneau Police Department 2021 Annual Report to the community.

2020 was an unprecedented year for law enforcement. First, the entire nation had to come to grips with the worldwide Covid-19 pandemic. Juneau was no exemption as the entire



community worked to mitigate the effects of the virus. Social distancing is sometimes unavoidable for police officers, and we worked through issues concerning decontamination, virus testing, and quarantining, just to name a few.

Second, all law enforcement came under increased scrutiny following several notable national incidents involving police brutality and excessive force. Social justice demonstrations occurred throughout the nation, including two peaceful protests in Juneau. JPD participated in an online listening session, met with concerned citizen groups, and posted our Regulations Manual online. JPD continues to proactively engage with the people of Juneau to assure we are working with the citizens we serve and allowing opportunities for citizens to provide input.


Crime trends in Juneau during this unprecedented time were also affected. Calls for Service fell to a five-year low, from 52,204 in 2016 to 42,781 in 2020. Part 1 UCR crimes also fell to a five-year low. Part 1 Crimes fell 22% with 1,597 crimes in 2019 and 1,246 crimes in 2020. Of the 8 Part 1 crimes, 7 crime categories had a decline, and 1 crime category had an increase. Each crime is addressed later in the body of this annual report. The overall reduction in crime should not be surprising given sheltering requirements and restrictions to businesses during the



pandemic. Monitoring future trends will be important as we emerge from the restrictions of the pandemic.

I would like to thank Mayor Beth Weldon, City Managers Rorie Watt and Mila Cosgrove, the entire City and Borough of Juneau Assembly, and all of the residents of Juneau for their continued support and efforts.





tion, operation, and management; over the years, however, the data have become one of the country's leading social indicators. The program has been the starting place for law enforcement executives, students of criminal justice, researchers, members of the media, and the public at large seeking information on crime in the nation. The program was conceived in 1929 by the International Association of Chiefs of Police to meet the need for reliable uniform crime statistics for the nation. In 1930, the FBI was tasked with collecting, publishing, and archiving those statistics.

Today, four annual publications are produced from data received from more than 18,000 city, university and college, county, state, tribal, and federal law enforcement agencies voluntarily participating in the program. The crime data are submitted either through a state UCR program or directly to the FBI's UCR Program."



Juneau Part I Offenses

The Juneau Police Department reports crime statistics, as federally required, to the State of Alaska and ultimately to the Federal Bureau of Investigation. JPD currently uses the Uniform Crime Reporting system. JPD reports in two types of prescribed offense categories, Part I and Part II. There are 8 Part I Offenses that are cataloged and reported. 


Juneau Part II Offenses

The Uniform Crime Reporting (UCR) Program divides offenses into two groups, Part I and Part II crimes. Each month, the Juneau Police Department submits information on the number of Part I offenses that become known; however, JPD also contributes arrest data for Part II offenses. 

Juneau Police Department 2020 Use of Force

The Juneau Police Department defines Reportable Use of Force as any force greater than a firm grip. In 2020 there were 46 incidents where force was used in comparison to 55 incidents in 2019.

PD strives to hire and train Officers who work with our community and gain voluntary compliance without the use of force when/where they can. Officers generally prefer not to use force on the community they serve. Officers receive extensive training and practice to develop conflict management skills to achieve this result. To the general public, the use of force is a difficult to comprehend and is not something most people are used to seeing. When a person, who is in a violent crisis or is impaired emotionally by anger, substance abuse, or other situations resulting in violence, they are not generally rational nor do they understand and comply with rational requests to stop the behavior that resulted in Officer contact. To use force on someone is not pleasant, nor preferred, but sometimes required to stop violence and gain control of a an offender. In the end, JPD works to return Juneau Alaska to "a place where people can live safely and without fear."

Juneau Drug Unit

uneau, like most cities, will at times experience illicit drugs coming into the community. The Juneau Police Department assigns officers to the Drug Enforcement Unit (DEU). The Juneau Police Department is part of one of three designated High Intensity Drug Trafficking Areas (HIDTA) in the state of



Alaska. The other two are in Anchorage and Fairbanks.

The Juneau Drug unit works in cooperation with other cities through Southeast Chiefs Against Drugs (SECAD) and HIDTA. The collaboration of the Southeast region's cities was formed to combat the drug problem that affects all of Southeast Alaska.

All manner of drugs, at varied times, come into the community illegally. These drugs range from marijuana to pharmaceutical opioid drugs. In 2014, Alaska voted to legalize marijuana for personal use, and the law took effect in February of 2015. However, even though marijuana is legal, there are still persons who conduct illegal marijuana operations. The most common drugs of abuse seen in Juneau are heroin, methamphetamine, cocaine, and marijuana. The cost of these and the other drugs of abuse can be devastating to the community both monetarily and to the loss of quality of life that occurs at varying levels up to and including death. All of these drugs have an impact on the well-being of our community, and often drug usage is concurrent with or causes other crimes.

On the following pages is a 5-year comparison (2016, 2017, 2018, 2019, and 2020) of the drug seizures and actions taken by the JPD Drug Unit. The lists on the following pages show the drug seizures and associated "street" costs of those drugs. "Street" cost of drugs relates to the amount of money the drug cost at the time of purchase.
