
The vessel “**21-Foot Grady White Model 205, HIN# TLOF723M76J**” will be impounded by the City and Borough of Juneau (CBJ) on **Monday, December 13th, 2021**. The Port Director under CBJ 85.25.130, “any boat in the boat harbor or in any of the municipal water which is abandoned may be impounded, removed, sold or otherwise disposed of as provided herein. Failure of any boat owner, master, operator or managing agent to register, pay moorage fees or service fees provided by this title shall be presumed to constitute an abandonment.” Because you have not registered or paid moorage fees for the “”, the vessel can be impounded consistent with CBJ 85.25.180.

As the **known** owner of the vessel, you are entitled to a pre-impoundment administrative hearing before a hearing officer to determine whether there is probable cause to impound the vessel. To request such a hearing, you must submit a written demand to the City Manager’s Office within ten days after; (a) you learned that your vessel will be impounded; or (b) mailing of this notice as required by CBJ 85.25.180(c), whichever occurs first. To request a hearing, fill out the enclosed form and file it with the City Manager’s Office at 155 South Seward Street, Juneau, Alaska, 99801.

If timely requested, a hearing will be held before a hearing officer appointed by the City Manager within 48 hours of receipt of your written demand (excluding Saturdays, Sundays, and City holidays); unless you waive your right to a speedy hearing and request a later date. In the event the hearing officer determines there is probable cause to impound the vessel, the hearing officer will prepare and date a Certificate of Probable Cause, copies of which will be given to you and the Harbormaster. Upon receipt of such a certificate, the Harbormaster may proceed with impoundment and disposition of the vessel by removal, sale, or destruction as authorized by CBJ 85.25.180(g) – (i).

This Notice has been posted on the “**21-Foot Grady White Model 205, HIN# TLOF723M76J**” at **Statter Harbor**, in the Harbormaster’s office, the Port Director’s office, the City Clerk’s office, and on bulletin boards at the entrance to U.S. Post Offices.
