The October 3, 2023 Regular Municipal Election will be conducted as a By Mail Election. As such, <u>CBJ Code 29.07.050</u> governs the timing of the election and the candidate filing period. Candidate nominating petitions can be printed and signatures gathered any time prior to the closing of the Candidate Filing Period provided the completed petition packet is filed with the Clerk's office no later than the closing of the candidate filing period. The Candidate Filing Period opens at 8:00 a.m. on Friday, July 14, 2023 and closes at 4:30p.m. on Monday, July 24, 2023. Candidate filing packets must include the Declaration of Candidacy Statement, Nominating Petition signed by a minimum of 25 registered Juneau voters, and the Alaska Public Offices Commission Public Official Financial Disclosure Statement.

Per, <u>CBJ Code 29.07.050(e)</u>, Candidates may withdraw their nomination not later than 4:30p.m. on **Friday**, **July 28**, **2023**.

<u>CBJ Code 29.07.055</u> also provides candidates the option to submit an official candidate statement to be published on the municipal website. Candidates are asked to submit their candidate statements to the Municipal Clerk's office no later than **Monday**, **August 14**, **2023**.
