GENERAL INFORMATION

1. This range is not supervised. You are responsible for your safety and the safety of other range users.
2. Youth 17 years and younger must be supervised by an adult.

6. Keep the range clean: remove all litter including targets and target holders. Pack it in; pack it out!
7. Glass, furniture, electronic equipment, and food can not be used as targets.
8. Misuse of the facility or failure to conform to all posted range rules and the rules of this permit will be sufficient reason for denying future facility rentals.

CANCELLATIONS and REFUNDS

PLEASE INITIAL Credits and refunds for cancellations will only be given if notification is received at least two weeks prior to the reserved date. Requests for reschedules must be made at least three business days prior to the reservation date. There is no service charge for a reschedule or a credit. There is a \$10 service charge for refunds.

COMMERCIAL GENERAL LIABILITY INSURANCE

Commercial General Liability Insurance shall cover all operations by, or on behalf of, the Applicant providing insurance for bodily injury and property damage liability including coverage for premises and operations, products and completed operations, contractual liability, broad form property damage, and personal injury liability. Coverage shall be written on an occurrence based form. The minimum limits of liability shall be:

- \$1,000,000 each occurrence
- \$2,000,000 General Aggregate

The City and Borough of Juneau shall be named as an Additional Insured for this policy.
