- Lands & Resources (Mary Kay). No update.
- Parks & Rec (Ed). Reported the Sandy Beach outhouse blew away in a wind storm, so the only bathrooms for the area are at Treadwell Arena. Also, an 18-page document on Douglas Improvements is being reviewed, includes addressing light poles, drainage, and other improvements, but not repairs where needed. Ed suggests DAB invite Parks

- & Rec director and/or staff to present at a DAB-sponsored public meeting. Also, request that DAB be included in developing/commenting on draft reports such as this.
- Docks & Harbors (Joyce). D&H are discussing a Douglas Waterfront action item. Joyce alerted them that the Douglas Boat Harbor is in need of attention, and while some dredging has been done, it is generally neglected and disheveled compared to other Juneau area boat harbors—citing dirt pathways, porta potties instead of bathrooms, in need of paint, etc. Other members of the planning group agreed with her. She will attend the next D&H meeting, representing herself, and make comments to this effect, including requesting more funding and resources for the Douglas Boat Harbor. Mary Kay requested DAB invite the D&H director/harbormaster to attend DAB meeting to discuss these points, as well as landscaping and parking. MK suggested a public meeting to allow Douglas residents to weigh in, and requested invitations go to Susanne, Sandy Williams, Annette Smith.
- Treadwell Historical Society (Mary Kay/Joyce). No update.
- Douglas 4th of July Committee (Joyce). Reported upcoming activities of the committee, including the annual Christmas Tree Lighting on 11/25, followed by a free skate at the Treadwell Arena.
