I declare that I qualify for the office of School Board Member, as outlined in Charter section 13.2, AS 14.12.080, and CBJ School District Policies 0140-0149. I am qualified to vote in State elections; a resident of the municipality for at least thirty days immediately preceding the election; registered to vote in state elections at a residence address within the municipality at least thirty days before the municipal election at which the person seeks to vote; not disqualified under Article V of the Alaska Constitution; not an employee of the Juneau School District; and not a member of the Alaska Legislature.
