<ul> <li>Alaska regulations require owners, operators, contractors, and other persons who undertake certain demolition or renovation activities to ensure that an accredited asbestos inspector performs a thorough asbestos survey of the building or residence, or part of the building or residence, where the demolition or renovation operations will occur. This requirement does not apply if the demolition or renovation activities qualify for one of the exemptions listed below. If none of the exemptions apply, Naste Management requires that the customer or contractor delivering demolition or renovation wastes to a Waste Management facility for transfer, recycling, or disposal must provide a copy of the asbestos survey to Waste Management prior to or at the time of delivery.</li> <li>mportant Definitions. In particular, the following definitions are relevant: <ul> <li>"Asbestos" means the asbestiform varieties of serpentine (chrysotile), riebeckite (crocidolite), cummingtonite-grunerite (amosite), anthophyllite, actinolite, and tremolite.</li> <li>"Asbestos-containing material" or "ACM" means any material containing more than one-percent asbestos by weight.</li> <li>"Demolition" means the wrecking or removal of any load-supporting structural member of a facility together with any related handling operations or the intentional burning of any facility.</li> <li>"Renovation" means altering in any way one or more facility components. Operations in which load-supporting structural members are wrecked or removed are excluded.</li> </ul> </li> </ul>
