City and Borough of Juneau Delinquent Sales Taxes As of September 30, 2024

The businesses reported in this listing are delinquent in filing and/or remitting of sales tax. The sales taxes collected by merchants, in the normal course of business, are required by law to be held in trust for the City and Borough.

Failure to remit the sales tax <u>will</u> result in significant financial penalties and interest being charged. The penalty for failure to file is \$25. The penalty and interest charged for failure to remit sales tax when due is 5% per month, up to a maximum of 25%, plus interest at 14% per annum. The City and Borough is actively pursuing the collection of the taxes owed. For flagrant violations, merchants can be <u>and have been</u> charged with Class A misdemeanors. Class A misdemeanors are punishable by up to one year in jail and/or a \$25,000 fine.

The delinquent merchants listed in this report represent a small minority of the merchants conducting business in the borough. The vast majority of merchants comply with the filing and remitting requirements. The delinquent tax amount shown in this report represents less than 0.6% of the City and Borough's annual sales tax collections.
