Candidate Filing

2.1 Nominating Petitions

CBJ Code 29.07.050(a) states that "each voter signing a petition shall state on the petition information sufficient to determine whether the voter is a qualified Juneau voter."

Election officials will use the same qualifications as outlined in Election Policies and Procedures "1.3 Determination of Voter Qualifications – for Petition Signature Verification" to determine voter qualifications.
