When filing out your application be sure to:

- Completely fill out the form we cannot process it if any sections are left blank
 - Your residential address cannot be a PO Box, PSC Box, commercial address, or mail stop.
- Provide your handwritten signature, as shown on your government ID or voter registration card and the date you signed the form. Digital signatures are not allowed.
- Hand deliver, mail, fax, or email this completed application to CBJ Municipal Clerk's Office, or the CBJ Elections P.O. Box mailing address listed below.

Return your voted ballot as soon as possible. Voted ballots must be postmarked no later than Election Day October 7, 2025 (we recommend making sure they have a legible postmark) and received by the Clerk's Office no later than Monday, October 20.
