What is a Comprehensive Plan?

What is a Comprehensive Plan?

A 20-year roadmap to guide growth and development in Juneau.



What makes a plan comprehensive?

Long Term- looks 20-30 years into the future, sets the policy and investment agenda for the decades to come.

Addresses Broad Interests- covers a wide range of policies and investments - from land use and transportation and economic development to parks, natural areas, and historic resources.

Community-Driven - the community's opportunity to clearly document its values and intentions for the future.



Juneau's last Comprehensive Plan was adopted **12 years ago** in 2013.

Regular updates to Comprehensive Plans help communities respond to changing community priorities and conditions.

A lot has changed since the last Comprehensive Plan was adopted.














How do Comprehensive Plans result in real, on-the-ground change?



What makes a good comprehensive plan?

- Detailed assessment of existing conditions
- Understanding of emerging trends
- Meaningful public engagement
- Consideration of alternatives
- Incorporation of economic realities
- Policies that can actually be implemented
- A short, uncomplicated, and visually engaging document



Comprehensive Plan update process will take place in three phases.

Phase 1: Listen and Learn (January to November 2025)

What is this phase about?

- Raising public awareness about the Plan, process, and outcomes
- Research on existing conditions of CBJ
- Draft a vision statement based on community feedback
- Develop strategies to address critical drivers of change

How can the community get involved?

- Community Listening Sessions (Public Meetings)
- Community Survey
- Advisory Committee (AC)
 Meetings #1 3
- Planning Commission and Assembly Communications

Comprehensive Plan update process will take place in three phases.

Phase 2: Imagining Possibilities (December 2025 to June 2026)

What is this phase about?

- Develop policy-based scenario concepts for locations in Juneau
- Ideas for areas of growth, with policy concepts
- Compare scenarios using "reportcards"

- Scenario Choosing Workshop (Public Meeting)
- AC Meetings #4 8
- Planning Commission and Assembly Communications

Comprehensive Plan update process will take place in three phases.

Phase 3: Developing the Plan (July 2026 to June 2027)

What is this phase about?

- Develop goals, actions, and implementation matrix
- Develop draft Comprehensive Plan
- Prepare final documents with legal language ready for presentation to Planning Commission and Assembly

Advisory Committee Roles and Responsibilities

Advisory Committee Members will...

- Attend and participate in up to 12 bi-monthly (every-other month) meetings over the course of the project. Meetings will typically be 90 min-2 hrs duration.
- Provide input, skills, and knowledge towards specific topics and issues related to the Comprehensive Plan and process.
- Share what you learn during this process back with your friends, neighbors and community, and share any concerns or ideas you hear during the project duration with the project team.
- Attend community engagement events when possible.

The commitment window for the Advisory Committee is: April 2025 –May 2027 (25 months)

Advisory Committee Members will...

- 1. Weigh in on local conditions and trends.
- 2. Provide feedback on key decisions and policy recommendations.
- 3. Help to ensure that the community's voice is heard and considered in the decision-making process.
- 4. Advise the project team on community engagement strategy.
- 5. Deeply understand the Comprehensive Plan project and will be able to explain both the opportunities and potential obstacles we may encounter along the way, to friends, neighbors and community.
- 6. Message, share, and listen, sharing what they learn back with their communities and bring any ideas or concerns related to the Comprehensive Plan back to the project team.

The City and Borough of Juneau will...

- Give AC members reasonable notice before a scheduled meeting date, and try our best to accommodate AC member's schedules.
- CBJ commits to making meetings easy and accessible for members of the AC. Whenever possible, hybrid options will be provided.
- The project team will send meeting scheduling polls to find a time that works best for the majority of the group.




Scenario Planning and "Driving Forces"

The "Traditional" Planning Approach



- Assumes past trends will continue
- Misses emerging trends and uncertainties
- Reduces the useful life of a plan
- Puts communities in a disadvantaged position in the future

The Scenario Planning Approach



Why include scenario planning in a Comprehensive Planning process?



Raises awareness of emerging trends that may impact the community



Minimizes "blind spots" in the plan and increases its useful life



Focuses discussion on policies that will help the community to manage risk



Provides a reference case for what could happen if policies stay as they are




The Scenario Planning Process
