AFFIDAVIT OF PETITIONER'S COMMITTEE CITY & BOROUGH OF JUNEAU, ALASKA

Proposing enactment of an amendment to the City and Borough of Juneau, Alaska Charter to raise the cap on the property tax millage rate in the City and Borough of Juneau.

Reference: CBJ Charter Article XIV, Section 14.3.

WHEREAS, reducing the property tax millage rate cap has added pressure for cuts to beloved services, programs and facilities enjoyed by the families and citizens of Juneau, Alaska; and,

WHEREAS, the loss of beloved services, programs and facilities will have a significant impact on the lives of citizens of the City and Borough of Juneau, Alaska,

NOW THEREFORE, the citizens of Juneau propose enactment of the following amendment to the Charter of the City and Borough of Juneau, Alaska:

**Charter Amendment Short Title: Mill Rate Cap Change
SHALL THE CITY AND BOROUGH OF JUNEAU CHARTER
SEC 9.7 BE AMENDED AS FOLLOWS:**

*** Section 1.**

... (c) Except as provided in this section, the assembly shall not levy on real or personal property any tax exceeding the total of ~~9 mills~~ 12 mills plus that additional millage required to service general obligation indebtedness. The assembly may levy a tax exceeding this total only after seeking and securing voter approval by a majority of those voting on the question at a general or special election.

*** Section 2. Effective Date.** This measure shall be effective 30 days after enactment.

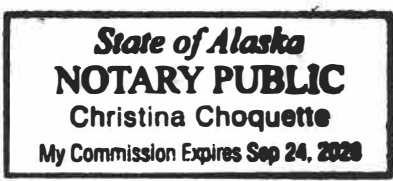
