WHEREAS, this initiative proposes a yearly season 1% sales tax increase, from May 1 to September 30. This sale tax increase will be in addition to all existing voter approved sales taxes. This tax will help generate additional funds during the busiest sales months.

WHEREAS, the intent of this additional seasonal sales tax revenue will help fund indoor and outdoor recreation in Juneau.

NOW THEREFORE, the citizens of Juneau propose enactment of the following to the Code of the City and Borough of Juneau, Alaska:

SHALL THE CITY AND BOROUGH OF JUNEAU CODE BE AMENDED AS FOLLOWS:

Section 1. Amendment of Section. CBJC 69.05.020, Imposition of rate, of the Code of the City and Borough of Juneau is amended to read as follows:

(a) There shall be levied and collected a tax equal to the percentage of the selling price on retail sales and rentals made and services performed within the City and Borough as follows:

(5) Within the entire City and Borough an additional one percent from May 1 to September 30.

Section 2. Effective Date. This initiative shall be effective 30 days after enactment.

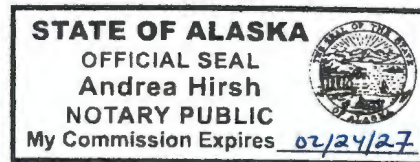
